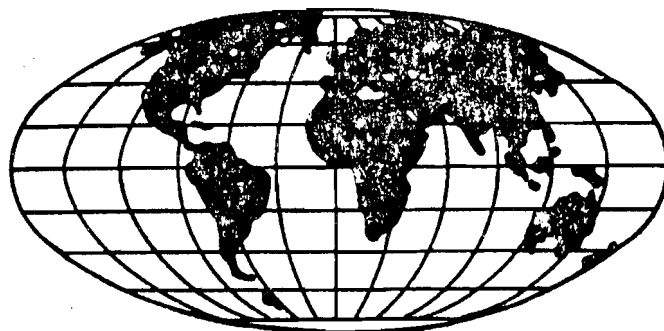
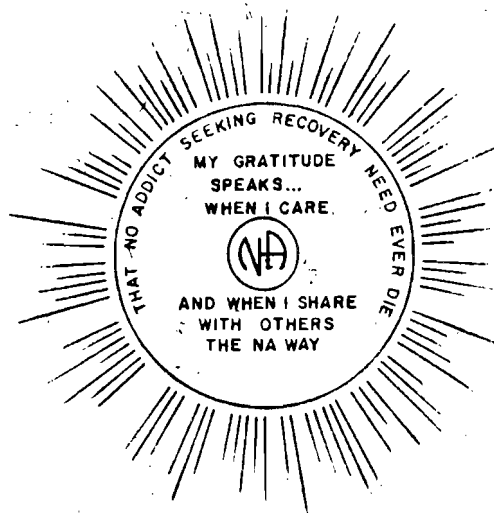

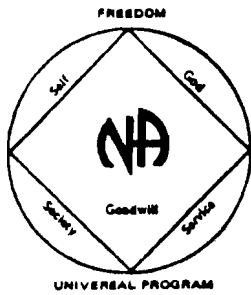

Greetings from the 1981-82 World Service Conference Administrative Sub-committee. So much has happened since the Conference last May and work on the agenda for the 1982 World Service Conference is underway. This past year has been packed with many events and much service work throughout the Fellowship which will need to be addressed at the Conference.

It has been brought to the attention of this Sub-committee, the need for an extended Conference this year. This would allow more time to adequately cover our agenda, so as to give each item the consideration it deserves. In suggesting that the Conference be expanded by two days, we discovered that a two-thirds majority vote of Conference participants is needed to change the length of the Conference. So we polled the Conference participants by sending out ballots.

As a Committee we are recommending that this year's Conference be held at the Retail Clerk's Union Hall on the Second Street, in Santa Monica, California. The proposed dates are Wednesday evening, May 5th. thru Sunday, May 9th. To adequately cover the concerns of the Fellowship and take action to meet the needs, the extra time will be invaluable.

Any input to be placed on the pre-Conference agenda should be sent in now, for inclusion in our next mailing. This is important for the voting participants who will be attending the Conference to have time to obtain a consciousness on major issues to be discussed.

This is a summary of the activities of the WSC Literature Committee to date and a report on upcoming events and needs of the Committee. It is important information that all members need to familiarize themselves with so they can be informed and gain insight into the importance and necessity of the activities of this year.

The WSCLC held WLC-4 in Santa Monica in the last week of April 1981. The Memphis Review Form (grey book) had come out in February, 81, and we had a lot of input which was factored into the existing material. The material was then edited by a four person team for grammar, punctuation, style, flow and content in an effort to prepare the book for WSC approval. All existing stories were edited for grammar, punctuation and style but were not approved in group conscience by the Literature Committee.

WLC-5 was held in Warren, Ohio, in June '81. Chapters 1, 2, 3, and 8 were rewritten, edited and Conference approved to be final form. We also worked on Sponsorship, Teenage Addiction and Just For Today pamphlets, an Approach to the Fourth Step Inventory, and a Hospitals and Institutional Handbook.

WLC-6 followed WCNA-11 in Miami in September. At Miami Chapters 4, 5, 6, 7, 9 and 10 were rewritten, edited and Conference approved to be final form. In the editing process the second half of Chapter 4, Living in Program, was incorporated into Chapter 9. We had completed the Basic Text Chapters. Arrangements were made to have the text printed and mailed in Memphis by the MSRSC. They did an excellent job.

The WSLSC held two meetings at the MSRSC in November. Elections for Vice Chairman took place due to the unexplained absence and inability to contact the Chairperson. Jim M. was elected and Page C. was elected as Co-Vice Chairperson. Two weeks later Jim M. stepped down and Page C. became acting Chairperson. At our meetings we tentatively agreed to have three Conferences: the first to compile and edit the stories in Philadelphia in mid-January, the second in St. Louis to approve the stories and to work on pamphlets, and the third in Atlanta to print and mail out Our Stories. We soon realize that time did not allow for three Conferences since the material will go out non-profit, which takes 2-6 weeks for delivery. The material has to be out by the last week in January to meet the 60-Day prior to WSC deadline.

The WSCLC held a three day Conference in Philadelphia the 15-17 of January '82 to review Our Stories and obtain a good crosssection of recovery experience in Narcotics Anonymous. At the close of the Conference we had over forty approved stories including five from other countries. Our hats go off to the Philadelphia Fellowship for their long and productive hours. Also our Thanks to the Members who journeyed from other states to lend their support and be a part of the work in progress. The local Fellowship had fundraisers, dug deep in their pockets for the \$275.00 they donated. The WLC sent \$300.00 and some how our expenses came to \$578.00, \$3.00 over what we had! We had what we needed. 1

Atlanta has a non-profit stamp and several competitive printers but in checking prices it would cost over \$4,000 to have 3,000 copies of the stories printed. Memphis can have the printing done for less than \$2,000, so we are sending them the stories.

We would suggest that as many Areas and Regions as possible hold Service Conferences so Our Book can be reviewed. The Appendix of the Memphis Review Copy (grey book) also needs to be reviewed to determine if it is valid and complete. We would like to include the History of each Region and Country in the Appendix, and a letter to this effect is soon to be mailed.

To complete this work we need money. When Page became acting Chairperson of this committee in December, our treasury stood at \$22.24. We contacted the Administrative Sub-committee of the WSC and requested a monthly allowance of \$60 and also requested that our set prudent reserve of \$500 be transferred to our account. This brought our account to \$582.24. The world mailing which went out cost \$292.54 for postage, \$197.19 for printing and \$2.44 for glue which totaled \$489.73. Our account stood at \$92.51 and we have a lot to be done within the next two months. One mailing had to go out first class due to the time frame in which we had to work with. The MSRSC sent \$500.00 which came from the donations they have received for the Approval Form of Our Book. They informed us that requests are many and donations are somewhat slim. Our current WSCLC balance stands at \$392.51 and we have requested \$1,000 from the WSC. From now on, all mail will go non-profit. We would like you to consider having fundraisers and giving personal donations to help us complete our work. We need money and we need it now and for the hardback publication of Our Book in the near future. Any and all donations will help. You may gain some insight on our insistence of donations by reading the last paragraph on page 33 of the proposed revision to the Third Edition of the Service Manual (green manual).

The issue of unapproved literature is a grey area in our existing policy. The need for new literature is apparent and the cost of printing and distributing literature is not cheap. In the past we have distributed literature free when possible. With the approval form of the basic text, we asked for donations and to date we are in the red. We are in the process of printing and mailing non-profit, the story section in order to have it out in 60 days prior to the WSC. Our donations will make this possible. Send donations earmarked for Literature to: Treasurer, WSC, P. O. Box 41323, Memphis, TN 38104. Our future options on this matter are: a) Regions pay for it all, b) Members pay for it all, c) Groups and Members pay a set donation as they go - Groups paying when possible and Members in all cases.

We are extremely grateful for this opportunity to express our thanks to all who attended and provided invaluable support to the Mid-South Regional Service Conference. Also, to the many concerned and dedicated members who could not attend but sent their spiritual, emotional and financial support for Our Book and the conference itself.

Members from 19 states initiated and continued work on information pamphlets, stories and handbooks. Some of which included: Cooperation Not Affiliation, Avoiding Relapse In Illness, Sponsorship, H.&I., the Service Manual, Triangle of Self-Obsession, An Approach to the 4th Step. In our review of the Stories, it was determined that a more varied selection was needed. This work is in process in Philadelphia and Georgia.

The MSRSC requested input from individual members, areas, regions, and the WSC Sub-Committees. We received both written and verbal suggestions as to the Fellowship's needs. The WSC Policy and Literature Sub-Committees held meetings. Also, a member of the World Service Board of Trustees was in attendance.

We attempted to provide an atmosphere of recovery, unity and service. Guided by our Service Structure we, as a Region, "initiated work to be finalized at the WSC". The Proposed Revision to the 3d edition of our Service Structure evolved to be the most complete work produced at this Service Conference. Group conscience also supported other material. This work is in the process of being completed by attending members and their Regions in cooperation with the WSC Literature and H.&I. Sub-Committees. May the God of your understanding be with you, for there is unity through service.

In the spirit of unity and willingness; in striving to better carry the message of recovery; in having faith in a Higher Power we accepted responsibility for the printing and distribution of the approval form of Our Book, the basic text on N.A. recovery from addiction. Nearly 2800 of the 3000 copies of the Approval Form and all of the proposed revisions to the 3d edition of our Service Structure have been distributed. Written and verbal communication on a world-wide level is expensive, as is quality printing even though we do a great deal of the work. Our finances are strained and the WSLC has requested \$1,500 from the WSC to help with the printing of the Stories. If it were not for the faith that we will get what we need, we would worry. Although, "Faith without works is dead."

A complete financial report and the minutes of the Service Conference including the Sub-Committee meetings and workshops will be available next month to any member upon request. Thank you for allowing us to continue to serve. We remain clean and crazy a day at a time in Memphis.
